## Wintering on the Costa del Sol

Going somewhere warm in the winter is always a good idea, and when this can be combined with visiting a different culture it is an even a better idea. This is just what Carol Stalker (Professor Emerita of Social Work) and her husband, Greg McCaughey, have done in wintering on the Costa del Sol in southern Spain. They joined us on April 28 to discuss their time on the Costa del Sol, tempting us all to go there. Carol and Greg had gone to Florida for many winters but, wanting a better experience, decided to try wintering in the Costa del Sol. They thoroughly enjoyed their visits and have returned many times.



They stay in one of the towns of the Costa del Sol on the Mediterranean Sea. With the beaches and the backing of mountains, it is a very attractive area. The climate in winter is moderate, with an average daily high in February of 18 degrees and 19 in March. There can also be days with the temperature in the 20s. Most days are sunny – it is the Costa del Sol, the Coast of the Sun. The area is as safe as here.

Winter on the Costa del Sol is the off-season. Plenty of accommodation is available at reasonable rates. This year suitable two-bedroom apartments with sea views were available for CAD\$1,800 to CAD\$2,200 per month. These apartments are very comfortable, although the furnishings and kitchen accessories may be somewhat spartan – proba-

bly bought at IKEA. Higher and lower rental places are also available. Transactions are done in cash, with ATMs giving better exchange rates than charge cards.




Since this is a tourist area, practically all amenities and services are available, including modern grocery stores, shopping malls, organized tours, tourist information offices, and a wide variety of restaurants. Food, transportation, beer, and wine are usually cheaper than in Ontario. As the Costa is major market garden area, plenty of fresh vegetables and fruit are always available. Carol and Greg believe the quality, freshness, and taste of produce are better than at home. Plenty of fresh seafood may be found in stores and at restaurants.

Greg showed many pictures of Carol and he enjoying their visit. The sun was always shining. Dining at a restaurant with a patio was particularly popular – they try to do this once a week. Restaurant meals are both excellent and reasonable.

The language is usually only a minor issue. With British folk living in the Costa area and lots of visitors, many stores and businesses have some English-speaking staff and most restaurants have multi-language menus. But you may want to learn a little Spanish to thank people and ask basic questions like: Where are the toilets?

Exploring the area is worthwhile. Nearby cities and towns can be reached by bus. Local and inter-city bus services are available, with senior rates. Rental cars are also available. Many historical sites, including Moorish and Roman sites, can be visited. There are plenty of golf courses in the area but they tend to be expensive.

Visitors usually get to the Costa del Sol by flying to the major airport of the region in Malaga. Bus and car services are available from Malaga to towns in the area. There are



few non-stop flights from Canada to Malaga so a flight to a European city and a connecting flight to Malaga will usually be necessary. Carol and Greg have sometimes stopped over in a European city on their way to Malaga. They have also flown Air Canada to Madrid and taken a train to Malaga.

This was a fascinating presentation. Carol and Greg have obviously enjoyed themselves and, no doubt, many of us are now tempted to visit the Costa while the snow falls here. For those thinking of going, the descriptions of their trips and their advice and recommendations are invaluable.

# Highlights of the Annual General Meeting, May 28, 2023

#### **Present**

### **Business Arising from Minutes of 2022 AGM**

Gerry Schaus noted no need to thank him for his service as President since that was done with flair in 2022.

Frank Millerd noted that membership renewals will be addressed. A reminder will be sent in August to those who need to renew. October is the point when renewals are due. Retirees who have reached the end of their one-year free trial will be encouraged to join.

### **President's Report**

Gerry noted that our hybrid meetings are working well with a good turnout both in person and on Zoom. He sees this as a positive outcome of the pandemic, such as permitting colleagues in remote locations to stay in touch with the Association.

We have found a suitable place for continuing with Pub Nights on occasion.

There were excellent "Birds and Bees" presentations for which Jan Overduin was the primary organizer. A halfdozen other presentations were enjoyed by members both in person and via Zoom over the fall and winter terms.

### **Treasurer's Report**

Ed Linder summarized the financial status of the Association, which of necessity was not quite complete. However, Ed was at least 95 percent sure of his numbers.

In May 2022 our bank account stood at \$7140.00. Having received no revenue from memberships in the past year and a small amount of income which came from rebates from CURAC, we currently have a balance of \$6156.00 (14 percent below last year).

Expenses included \$541 for meetings, \$246 for CURAC membership, \$230 for equipment, and \$140 for the year's Zoom subscription.

### Report on the Laurier Pension Plan (LPP)

Alistair Robertson summarized the past year of the pension plan.

In the most recent three-month period (first quarter) LPP earned 4.5 percent.

For 2022 the LPP did better than most other investments, returning a negative 1.7 percent on the year.

The LPP was fully funded at 101 percent at the end of 2022.

Current negotiations are determining steps toward joining the University Pension Plan (UPP), which would combine the Laurier plan with that of several other (typically larger) universities in Ontario. WLUFA has agreed to hold a membership vote. If WLUFA agrees to proceed, the University will approach the other stakeholders (including the retirees) to determine their wishes.

### **CURAC Report**

Frank Millerd reported on CURAC (College and University Retiree Associations of Canada).

CURAC publishes a series of newsletters that Frank recommended as good reading for retirees. Other valuable services include connecting retirees with travel insurance and other insurances, including in our case a link with the Retired Teachers of Ontario (RTO). University employees are welcomed as members of RTO. This can be a valuable connection in that a surviving spouse of an RTO member can join RTO and gain access to a broad range of health

and travel insurance. Coverage from the University plan terminates two years after the death of a spouse who was a Laurier employee, meaning that the RTO connection may be vital.

### **Slate of Nominees**

Key changes from the list of nominees are that Jim Butler has accepted his nomination as President. So Gerry Schaus will now be Past President instead of Frank Millerd. Joan Kilgour is added as a member-at-large, and Shannon Purves-Smith agreed to work with Doreen Koenig as Social Convener. All members present and on-line agreed with the slate.

### **Looking Ahead**

Frank asked that all members consider helping with program coordination, and Gerry encouraged the executive, especially, to assist.

## Memories of Jan Overduin (1943–2023)

In 1986 I was one of seven students in the first class of Laurier's BMT (Bachelor of Music Therapy) program. Since we all had music degrees and had completed our psychology courses, we were able to complete the BMT in just two years.

The Faculty of Music was housed in MacDonald Hall where Jan Overduin taught us improvisation in a small room that could barely hold an upright piano, let alone all of us. He had never taught music therapy students, but his musical intelligence, and his discussions with Dr. Rosemary Fisher (BMT Director) informed him that most music therapy clients would not want to hear an improvised fugue!

Jan asked us to describe and notate our musical ideas

in an improvisation notebook. I still have mine, 36 years later, and reading it takes me back to Jan's inspiring classes. His improvisation knowledge and compassionate creativity opened a new world for me as a classically educated pianist. I loved the process of creating improvisations, never quite sure how my musical ideas would play out, and it felt liberating to play music without a score. At the end of one of my notated improvisations, he wrote: very imaginative melodically & rhythmically, a fine improvisation. Thank you sir.

I'm eternally grateful to Jan and his teaching because his musical empowerment allowed my career to include performing improvisation concerts with colleagues such as Casey Sokol (York University, retired), and teaching clinical improvisation to music therapy students.

### **About the Author**

I studied piano performance at the University of Manitoba with Boyd McDonald, and later was in the first class of WLU's Bachelor of Music Therapy program. I have an MSW from WLU and a doctorate in music therapy from New York University. From teaching music therapy (and serving as Coordinator of the Master of Music Therapy program for nine years) at WLU, I'm Associate Professor Emerita. Currently I perform duets and a two-piano repertoire with my life partner Boyd.

### **Pension Update**

### **Pension Plan Estimated Funded Status**

In September 2023, the Pension Committee of the Board of Governors, meeting jointly with the Finance, Investments, and Property Committee of the Board, received estimates of the funded status of the WLU Pension Plan at January 1, 2023. The value of the plan's assets were compared to its pension liabilities on both a going-concern basis, which assumes that the pension plan will continue indefinitely into the future, and a solvency basis, which assumes that the plan terminates at the date of the valuation.

At January 1, 2023, the Laurier plan had an estimated going-concern funded ratio (assets divided by pension liabilities) of 104 percent, yielding a going-concern funded surplus of \$29.5 million. This is an increase from a going-concern funded ratio of 102 percent and corresponding surplus of \$20.1 million at December 31, 2021, the date of

the last-filed actuarial valuation. When estimated on a solvency basis, the plan had a funded ratio of 111 percent at January 1, 2023, yielding a solvency-funded surplus of \$86.8 million. This represented an increase from a solvency-funded ratio of 104 percent and corresponding surplus of \$36.2 million recorded at December 31, 2021. These increases in funded ratios occurred largely because a decline in the value of pension fund assets over 2022 was more than offset by a decrease in the present value of future pension liabilities as rising interest rates contributed to an increase in the applicable discount rates.

### The Ontario University Pension Plan (UPP)

In July 2023, Wilfrid Laurier University and the WLU Faculty Association (WLUFA) reached an agreement under which WLUFA committed to provide consent on behalf of its members to convert the Laurier Pension Plan (LPP) to the University Pension Plan (UPP), the jointly sponsored, defined-benefit pension plan for the Ontario university sector, which began operations in 2021. Laurier has been exploring the option of joining the UPP with its employee unions and associations. The agreement between the University and WLUFA is an important milestone in the progress towards an eventual transition from the LPP to the UPP. The University will now pursue similar agreements with other unions and employee groups at Laurier. Pension conversion can occur only if at least two-thirds of active (employed) members of the Laurier Pension Plan provide their consent and, in addition, no more than one-third of retired and deferred vested members of the LPP object to such conversion. At January 1, 2023, there was a total of 3,267 members of the LPP, including 1,920 active members, 699 retiree members and beneficiaries, and 648 deferred vested members.

### **Pension Fund Rate of Return**

In 2023 Canadian pension funds benefited from a rebound in stock markets from the lows reached in 2022. The latest figures reveal that over the seven months from January 1 to July 31, 2023, the Laurier pension fund earned a year-to-date rate of return of 6.15 percent. This result stands in sharp contrast to 2022 when, as a result of losses in the equity and bond markets, the pension fund earned a negative annual rate of return, -1.72 percent.

## **CURAC Affinity Agreements**

Please mention that you are a member of the Wilfrid Laurier University Retirees' Association when applying for coverage under any of the CURAC affinity programs. Some programs provide rebates to our Association.

### **Registered Teachers of Ontario Plans**

Members of WLURA may join the Retired Teachers of Ontario (RTO) and participate in RTO's group plans. You must be a member of RTO (fee is \$73 per year) to join an RTO group insurance plan, but you can join RTO without joining an RTO plan.

### **RTO Extended Health Care Plan**

- Pays for eligible expenses that are recommended as medically necessary but are not normally covered by a government health insurance plan.
- Includes, with some limitations, prescription drugs, vision care, eldercare guidance, paramedical practitioners, aids and appliances, accidental dental, and guidance on treatment options.
- Comprehensive travel medical insurance for 93 days per trip.

Retirees not now members of WLU or another extended health care plan, or those wishing additional insurance, may join RTO and the RTO Extended Health Care Plan. RTO members currently in Laurier's plan will be accepted into the RTO Extended Health Care Plan without a medical questionnaire. Coverage is also available for a spouse and dependent children.

## Joining RTO to ensure that the surviving spouse or partner is eligible to join RTO group plans:

- The surviving spouse of a deceased retiree may join RTO and RTO's plans only if the deceased retiree was an RTO member at time of the retiree's death.
- After a retiree dies, health and dental benefits from Laurier for a surviving spouse and eligible dependents continue for two years.
- A surviving spouse who joins the RTO plan within two years of the retiree's death and is still a member of Laurier's Group Benefits Plan will be accepted into the RTO plan without a medical questionnaire.

RTO does not offer stand-alone travel insurance but their full extended health care package includes competitive travel and trip-cancellation insurance.
